Course objectives and Learning outcomes: the course concerns regulation, organization and activity of the public administration, also in the light of European integration. The course is aimed to providing students the knowledge of the most relevant institutes of administrative law. The independent regulatory agencies, which the monographic section of the course is dedicated, will be considered in this context.

PROGRAM

General section Administrative law. Administrative power and administrative function. History and evolution. Public Administration's activity. Public Service. – Sources of administrative system. – Administrative power and subjective legal situations. Public organization, public administration and organizational relationship. Independent regulatory agencies. The public administration in the light of the Italian Constitution. Politics and administration. – Principles of administrative law. – The public employees. – The discretion power and the so-called "technical discretion". - Administrative procedure and access to documents. – Acts and administrative measures. Act's effectiveness and invalidity.- The administrative simplification - Administrative agreements - The activity of private law of the public administration - Regions and local authorities. The administrative system after the reform of Title V of the Constitution – General features. Control procedures; public property and resources of the administrative activity; The civil liability of the public administration. – Protection of subjective legal situations. General concepts.
